- Gibraltar, the subsistence allowance and accommodation limit shall be as in Great Britain,
- Hong Kong, the subsistence allowance shall amount to 55 USD and the accommodation limit – 250 USD,
- Taiwan, the subsistence allowance shall amount to 40 EUR and the accommodation limit – 142 EUR.
